**SUBJECT:** AGRICULTURAL PESTICIDE USE NEAR SCHOOLSITES

The California Department of Pesticide Regulation (CDPR) has adopted new regulations which additionally regulate agricultural pesticide applications near public K-12 schools and licensed child day care facilities (collectively called schoolsites). These regulations took effect on January 1, 2018 with a goal of providing additional protections to school children when agricultural pesticide are applied nearby.

California growers with fields that are within a quarter mile of a schoolsite must notify the principal or administrator by April 30<sup>th</sup> of all pesticides they expect to use for the following July-June school year. Schoolsites do not include family day care homes or private schools. Notification must include all pesticides, even organic materials and those which are exempt from pesticide registration.

## CCR §6692 Annual Notification

- (a) For all applications of pesticides expected to be made for the production of an agricultural commodity within ¼ mile of a schoolsite, the operator of the property to be treated shall provide annual notification to those specified in (b) no later than **April 30** of pesticide(s) expected to be used from July 1 of the current year through June 30 of the next year.
- (b) The annual notification must be provided to:
  - (1) The principal of the public K-12 school
  - (2) The administrator of the child day care facility; and
  - (3) The county agricultural commissioner

These new regulations **restrict certain types of pesticide applications made within a quarter mile of a schoolsite** during school hours, Monday – Friday from 6 a.m. to 6 p.m. These include applications by aircraft; sprinklers, airblast sprayers, fumigants and dust applications, such as sulfur. Pesticide applications involving backpack sprayers and ground rigs without forced air can occur during the 6 a.m. to 6 p.m. period as long as they are more than 25 feet from a schoolsite. Greenhouse applications are exempt from the minimum buffer requirement.

You can view the schoolsites within ¼ mile of your agricultural sites and **submit your annual notifications online** in CalAgPermits.org, if you have an Operator Identification Number (Op ID) or Restricted Material Permit, and a web logon. Growers must keep a copy of notification for 2 years. If you need to use a material not on the initial notification, an amendment must be submitted and schoolsites notified 48 hours prior to use.
