Thanks Camille. Here is the draft nesting bird survey for SWCA review.

With regard to the neighbor emails regarding a white-tailed kite nest in a tree behind the house at New Brunswick and Cowpens, we have been aware of that nest for some time. Our assessment, based on its location out at the end of the tree branch, and a large hole that is present in the bottom of the nest, is that this is not a kite nest. Kite nests are typically well camouflaged, particularly from below. The kites were observed during this survey, and have been observed in the area on other non-survey days. They apparently are tolerant of human activity.

Let me know if there are any questions. I am in the field in the morning, but will monitor emails tomorrow and through the weekend.

Hello Tay,

We received the attached email from an adjacent property owner. The community is concerned that two nests were missed during the last nesting bird survey: white-tailed kite and western bluebird. They have attached photos, none of which show an active nest (containing eggs or chicks) or fledglings...so I am not sure if "active" nests are actually present where suggested. Regardless, please make sure these areas are thoroughly inspected during the survey. Since western bluebirds are cavity nesters, a nest may be difficult to detect if the tree is located on an adjacent lot which you don't have access to. Perhaps requesting access to adjacent properties would help ensure all nests are detected. I will leave that up to MIG and NextGen to decide and/or coordinate.
