Good morning Camille,

Yesterday I sent a written request of Cornerstone to respond to the three letters (including the attached) as Ron requested I send to him. The problem with the response (and the timing of same) appears to be centered around the passing of the engineer who wrote the original report(s) and did the vast majority of the work. Cornerstone has to decide who would work on the responses.

My email to them yesterday contained no ambiguity regarding the importance of and the substantial time pressures present regarding their reply.

I would be surprised if Cornerstone will comment on the legal requirements which the County has imposed or the sufficiency of same which make-up the bulk of the May 17 letter, but I have elected to say nothing about that to them to let them respond if a particular area covered by the letters from counsel to the neighbors is outside of their scope of work.

You mentioned having to hire another consultant to reply if Cornerstone does not reply soon. I believe that process would mean the death of grading this year, so we are doing all we can to encourage Cornerstone to cooperate and to do so quickly.
